# **Meeting Minutes**

June 2, 2021

### **Old Business**

- -- Board of Directors Election: Voting was conducted using ElectionRunner closed on Monday, May 31. The results were as follows: Denise Alexander 42; Barb Silvey 41; Holly Weyrauch 39; Siamak Hajarizadeh (write-in) 1. Denise, Barb and Holly begin 3 year terms starting July 1, 2021 and ending June 30, 2024. Siamak is currently on the Board and not up for re-election until 2022. The vote count represents 75% of paid members.
- Sectional Mentorship Program: Scott moved, Denise 2<sup>nd</sup>, formation of an ad-hoc Mentorship Committee in accordance with the proposal prepared by Denise to improve mentorship and recruiting in connection with the current shadow assigning process. Discussion centered on the relationship of the proposal to shadow assignors and duplication of USTA Mentor program. Shadow assignors are already connected with recruits and it is unclear who would take on the additional communication and mentor responsibilities envisioned for the expanded program. Approved 6-2. Denise (chair) and Barbara volunteered for the committee and to draft an updated proposal.

-- Honorary Memberships: The Awards Committee nominated John Flynn and Steve Halberg for honorary membership upon their retirement. The votes in favor were 8-0 and 5-2-1, respectively.
